- We will act on these tasks with an eye toward balancing the rights of the individual with the rights of the community


President's Report cont'

- Solar Lights for Mail Kiosks
















Treasurer Report May 1, 2010- May 1, 2011

HOA in good financial condition due to good contractor choices and increased collection of delinquent assessment accounts

- Operating fund \$126,000 (20% increase)
- Capital Reserves \$131,000 (17% increase)
- Assessment Delinquency down to \$31,000 (51% improvement). Thanks to HOA attorney and CMA

Deed Restriction Violations

- Lawn Maintenance- barren due to drought, shade and neglect
- Fence/Gate Repair and Replacement (Red Cedar 4 inch pickets only)
- Unapproved modifications- (patio covers, decks, sheds, major landscaping adjustments.
- Paint color changes

New revenue order/fining policy (received funds go to non-assessment liabilities (attorney fees, fines, force mows) first.

Board option to impose daily fines for recalcitrant owners

Likely 2011-2012 initiatives

- By-Law and Deed Restrictions revamped (Board, Attorney and member reviews and comments)
- Continue to advance maintenance suggestions from 2009 Reserve Study
- Revised ACC Guidelines
- More joint events with Ridge at Scofield HOA
